According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance,-

第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時買賣合約即告終止; (ii) 有關的臨時訂金即予沒收; 及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase – (i) the preliminary agreement for sale and purchase is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

A further deposit equivalent to 5% of the Purchase Price shall be paid by the Purchaser(s) within 30 days after signing of the PASP.

A preliminary deposit equivalent to 5% of the Purchase Price shall be paid by the Purchaser(s) upon signing of the preliminary agreement for sale and purchase (“PASP”). The agreement for sale and purchase shall be signed by the Purchaser(s) within 5 working days after signing of the PASP.
2. 相等於樓價 5% 之加付訂金須於買方簽署臨時買賣合約後 30 天內繳付。
A further deposit equivalent to 5% of the Purchase Price shall be paid by the Purchaser(s) within 30 days after signing of the PASP.
3. 樓價 90% 即樓價餘款須於買方簽署臨時買賣合約後 120 天內付清。
90% of the Purchase Price being balance of the Purchase Price shall be paid by the Purchaser(s) within 120 days after signing of the PASP.

A preliminary deposit equivalent to 5% of the Purchase Price shall be paid by the Purchaser(s) upon signing of the preliminary agreement for sale and purchase (“PASP”). The agreement for sale and purchase shall be signed by the Purchaser(s) within 5 working days after signing of the PASP.

5% of the Purchase Price shall be paid by the Purchaser(s) within 180 days after signing of the PASP.

(A) 一按按揭貸款條款

Key Terms of First Mortgage Loan

(Applicable to Purchaser(s) who chooses First Mortgage Loan Payment Plan only and who is/are individual(s) or limited company(ies) incorporated in Hong Kong)

買方可向由賣方指定財務公司「麗新財務有限公司」(「承按人」)申請一按按揭貸款，申請受以下基本條款及條件規限：

The Purchaser(s) can apply for a first mortgage loan through the Vendor's designated finance company, "Lai Sun Finance Limited" ("Mortgagee"), and the key terms and conditions are as follows:

1. 一按按揭貸款最高金額不可超過樓價的 80%。
The maximum amount of the first mortgage loan shall not exceed 80% of the Purchase Price.
2. 一按按揭貸款年期最長不可超過 20 年。
The tenor of the first mortgage loan shall not exceed 20 years.
3. 買方於提款日起息分期供款，首 30 個月之按揭利率為香港上海滙豐銀行有限公司不時報價之港元最優惠利率(P)減 1.5%p.a. (P-1.5%)，其後之按揭利率為港元最優惠利率(P)。P 為浮動利率，於本價單日期 P 為每年 5%。一按貸款額、年期及利率以承按人最終審批決定為準。賣方並無就其作出，亦不得被視為就其作出任何不論明示或隱含之陳述、承諾或保證。
Purchaser(s) will have to pay monthly installments and interest will be accrued starting from the day of drawdown. Interest rate for the first 30 months shall be Hong Kong Dollar Best Lending Rate (P) quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited minus 1.5%p.a. (P-1.5%), thereafter at Hong Kong Dollar Best Lending Rate (P). P is subject to fluctuation. The P as at the date of this price list is 5% per annum. First mortgage loan amount, tenor and interest rate shall be subject to final approval by the Mortgagee. No representation, undertaking or warranty, whether express or implied, is given, or shall be deemed to have been given by the Vendor in respect thereof.
4. 買方及其擔保人(如有)須提供足夠文件證明其還款能力，包括但不限於提供足夠文件證明每月還款(即一按按揭貸款還款及二按按揭貸款還款及其他借貸的總還款)不超過買方及其擔保人(如有)的每月總入息之一半。

The Purchaser(s) and his/her guarantor(s) (if any) shall provide sufficient documents to prove his/her/their repayment ability, including but not limited to, providing sufficient documents to prove that the total amount of monthly installment (being the total installment for repayment of first mortgage loan, any second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser(s) and his/her guarantor(s) (if any).

5. 買方申請按揭貸款時，須支付行政費用，金額相等於一按按揭貸款總額之 0.25%。若有關申請按揭未被批准，所有支付之行政費用將全數免息歸還。

An administration fee will be payable by the Purchaser(s) in the amount which is equivalent to 0.25% of the first mortgage loan amount when the Purchaser(s) apply for first mortgage loan. The administration fee will be fully refunded without interest if the application is not approved.

The Purchaser(s) is/are advised to enquire with the Mortgagee on details of terms, conditions for approval and application procedures of the first mortgage loan before selecting this payment term. All the above offers are subject to final terms and conditions as approved by the Mortgagee.

7. 所有一按按揭之法律文件必須由承按人指定之律師行辦理，買方須支付所有相關之律師費及雜費。

All legal documents of the first mortgage loan shall be prepared by the solicitors designated by the Mortgagee and all legal costs and disbursements relating thereto shall be borne by the Purchaser(s).

The Purchaser(s) may at any time repay the outstanding loan in full by giving the Mortgagee one month's prior notice in written without levy of early repayment penalty and administration fee.

The Mortgagee reserves the right to decide whether or not to approve the first mortgage loan. The approval or disapproval of the first mortgage loan is subject to the final decision of the Mortgagee and not related to the Milirich Investment Limited (which shall under no circumstances be responsible therefor). The Purchaser(s) shall complete the purchase of the residential property and shall fully pay the Purchase Price of the residential property irrespective of whether the first mortgage loan is approved or not.

如買方選用賣方指定之代表律師作為買方之代表律師同時處理其買賣合約、按揭契及轉讓契，賣方同意為買方支付買賣合約及轉讓契兩項法律文件之律師費用。
